We understand that the party will consist of a ten (10) minute warm-up, fifty (50) minutes of gymnastics, and thirty (30) minutes in the party room for food and beverages. We also understand that the party must end promptly, as there are usually parties following this one. **Should the party exceed the contracted time, there will be an additional fee.**

We agree to abide by the rules and regulations set by Gymland School of Gymnastics, LLC ("Gymland") regarding safe and prudent conduct and behavior by all participants and attendees. We also acknowledge that all participants are of sound medical and mental capability for the activities involved with gymnastics. We acknowledge that any sport involves physical risks including catastrophic injury or even death and indemnify Gymland and its' staff from liability towards any sustained injury unless due to gross negligence on the part of its' staff. **We also agree and accept responsibility of all participants and attendees for their behavior and to provide adequate supervision for them.** Participants only are allowed on the gym floor. **Only one (1) parent taking pictures is allowed with permission of the party staff.** Children under the age of 3 years must be accompanied by an adult on the gym floor. We endorse this agreement with full understanding of this contract with Gymland.

We agree to a security deposit which is non-refundable from the date of acceptance unless under the discretion of Gymland. **This security deposit is in the amount of \$100.00 and is required at the time of scheduling the party.** We also recognize that rescheduling the party is a hardship on the Gymland staff, and if a reschedule is necessary, we may lose the initial security deposit, and be subject to a new deposit fee.

**We understand that we are responsible for all food, beverages, paper and plastic goods such as but not limited to plates, cups, forks, spoons, napkins, and tablecloths for two (2) eight-foot tables.** We understand Gymland is responsible for providing two (2) eight-foot tables and an appropriate number of chairs. Gymland staff will also be responsible for any reasonable clean up and disposal of party materials.

We understand that the minimum payment for the party will be the approximate number given in advance as per the follow-up call which will be done the week of the party by Gymland. We understand that combined parties for 2 or more children will be subject to a \$50.00 fee for each additional birthday child. **If the party exceeds the package limit, there will a charge of \$15.00 per child.**

We understand that **the balance for the party is due on the Friday before the party** with any expenses exceeding the contract being collected immediately after the party.

**We also agree that no alcoholic beverages be brought upon or used at the premises.** Violation will result in immediate termination of the party with full payment due for the staff's time and efforts.
